

2020 TOWN OF MADISON PERMIT / FEE SCHEDULE

BUILDING PERMIT FEES

1. Residential; \$10.00 per 100 square feet or part thereof, plus \$10.00 for a single and \$15.00 for a double car garage (attached).
2. Commercial; office, industrial and warehouse buildings, \$5.00 per one thousand cubic feet or part thereof up to 1,000,000 cubic feet plus \$1.50 for every additional 1,000 cubic feet contained therein, but not less than \$30.00.
3. Detached garages; \$40.00
4. Additional car stalls (each); \$6.00
5. Residential Alterations and repairs; \$10.00 per \$1,000 expended or portion thereof, but not less than \$25.00
6. Commercial Alterations, remodel or renovation of existing, and repairs; \$11.00 per \$1,000. Expended or portion thereof, with minimum fee of \$25.00.
7. Open sheds; \$25.00
8. Fire escapes; \$20.00
9. Building demolition (razing); Residential \$150.00 Commercial \$250.00 for 20,000 cubic feet or less. Each additional 20,000 cubic feet an additional \$50 up to a maximum of \$450.00.
10. Canopies and awnings; thirty cents (\$0.30) per square foot of surface with a minimum fee of \$25.00
11. Antenna permit (dish type); \$20.00
12. Fences; \$30.00
13. Signs; one dollar (\$1.00) per square foot of advertising area, minimum fee of \$50.00
14. Swimming pools; \$50.00
15. Elevators; \$50.00
16. Moving buildings; \$250.00
17. Moving accessory buildings; \$25.00
18. Mobile Home or Manufactured Home Site Permit; \$25.00
19. Certificate of occupancy (residential); \$25.00
20. Certificate of occupancy (commercial); \$50.00
21. Change of use or occupancy inspection; \$25.00
22. Reissuance of permit; 1/2 of original fee
23. Communication towers; \$10.00 per \$1,000 expended or portion thereof.
24. Erosion control; Residential: \$25.00, Commercial \$35.00
25. Plan review; Residential: \$25.00, Commercial \$100.00. Plan revisions \$100.00
26. Early Start Permits for Buildings; Residential \$50.00, Commercial \$75.00

NOTE: Commercial permits expire one (1) year after issuance; Residential permits expire two (2) years after issuance.

HEATING, VENTILATING and AIR CONDITIONER PERMIT FEES

1. New Construction- 25,000 cubic feet or less; minimum fee of \$75.00, plus \$1.50 per thousand cubic feet or portion thereof over 25,000 cubic feet
2. Boiler or furnace replacement; \$50.00
3. Conversion gas burner; \$25.00
4. Fixed unit heater; \$50.00
5. Alterations or additions to existing heating systems; \$20.00 per each \$1,000.00 or part thereof
6. Air conditioner condensers, compressors, or heat pumps; \$30.00.

7. HVAC license for contractors; \$35.00

DEFINITION: The cubic content of a building shall be equal to the area of the basement or the lowest floor level in square feet multiplied by the height in feet from the lowest level to the average height of the roof.

PLUMBING PERMIT FEES

1. Fixtures; first 6 fixtures \$11.00 per fixture, additional fixtures \$6.00 per fixture.
2. Building sewer; Sanitary and/or Storm \$25.00 per 100 feet or portion thereof.
3. Minimum fee of \$20.00 per permit.

ELECTRICAL PERMIT FEES

Temporary Service: \$15 per 100 amps
Service Entrance: \$15 per 100 amps

Feeders or circuit; fees for installation of feeders, branch circuits, extensions or alterations to existing circuits shall be computed separately in accordance with the following schedule:

0-30 amp capacity: \$3.00 each
31-60 amp capacity: \$6.00 each
61-100 amp capacity: \$10.00 each
Each additional 100 amp capacity or fraction thereof: \$5.00
Minimum permit fee: \$20.00

ADDITIONAL AND MISCELLANEOUS INSPECTIONS

Re-inspections and inspections requested but not ready; Residential \$25.00, Commercial \$35.00 (applies to building, HVAC, plumbing, and electrical).

PUBLIC WORKS PERMIT/FEES

1. Excavation permit fees; \$70.00 per excavation or 100 feet of trench or directional boring; \$70.00 per additional excavation or 100 feet of trench or directional boring
2. Driveway permit; \$35.00
3. Street permit (parade or event); \$25.00
4. Temporary street use permit; \$35.00
5. Sanitary sewer connection fee; Residential \$100.00, Commercial \$200.00
6. Sanitary sewer connection inspection fee; \$50.00
7. Storm sewer connection fee; Residential \$100.00, Commercial \$200.00
8. Storm sewer connection inspection fee; \$50.00
9. Dumpster fee; Residential \$40.00/per dump (no delivery fee)
10. Dumpster fee; Residential building materials \$60.00/per dump (no delivery fee)
11. Dumpster fee; Commercial \$60.00/per dump (no delivery fee)

Fees for failure to obtain any permit listed above before starting work shall result in double the fees stated above, except as provided for in an emergency, and are subject to penalty under law.
